Alexis Nakota Sioux Nation Message from Alexis Chief and Council

Abawashded Metaudebi,

This report is presented to the Alexis members during the 4th Quarter Band Meeting on Friday, March 18, 2022 of the 2021-2022 fiscal and operating year. The report accounts for our office and activities. During this last quarter, we spent some time visiting with the Elders and members on community issues and our tribal laws. As we work through the drafting of our Constitution, these meetings are valuable and we appreciate the feedback we have received thus far. Our goal is to have a Constitution for our People written in our language. This work will continue for years to come and we will make every effort to keep our members informed and part of the process. Here are some highlights for this reporting period:

- Alexis Nakota Sioux Nation Agricultural Benefits Claim (2017): On December 10, 2021, our claim was filed with the Specific Claims Tribunal of Canada. (See page 12 for more details.)
- Pasa Tibi Center (2020-2022): In December of 2021, we completed the final phase of our planning for the new Elders lodge and our proposal is now under review with Alberta Health. The project will contain 18 'continuing care' suites that will be operated as part of Alberta Health Services continuing care program. Twelve will operate as either Designated Supportive Living or Long-Term Care; the remaining six are to be programmed as a recovery program. If approved, construction is likely to begin in 2022.
- Alexis Nakota Sioux Nation Constitution (2019): Our Constitution, when completed, will be the highest law of our Nation. On September 2020, a draft outline was shared with the Elders. It included all pieces of law. We continued working on the amendments to our Customary Election Regulations and developing a Peace Officer Bylaw. These laws are vital pieces to our Constitution and will bring positive change to the Nation. (For more information see page 13 & 14)
- Amendments to the Customary Election Regulations (1997): On February 10, 2022, we reviewed the amendments with members and opened it for feedback. The meeting went well and we will continue meeting and updating until the document is ready for final membership approval. (For more information see pages 13 & 14)

- Peace Officer & By-law (2021): On January 20, 2022, we reviewed a new law designed to employ a Peace Officer to deal with criminal activity and enforcing our laws. Moving forward, the Council put funding in place to hire a Peace Officer in the new fiscal year. (For more information see page 15)
- Alexis Healing Gatherings (2022): We held our First Elders Healing Gathering on January 19, 2022 and will continue gathering monthly to debrief and address the issues we have in our community. The first two sessions focused on addictions. As a Nation we carry a lot of trauma from the past, not only residential schools but also colonial warfare in our territory. The social problems that we accumulated over the years will take years to heal, and we must continue working and striving for a cleaner, healthier and safer community. At the last session, we invited one of our young members, (Joyce Potts), to present her idea to the Elders. She proposed a new way of connecting Elders with Youth. We invite all the Elders to continue participating and coming together to build a healthier community.
- Alexis Business Partnerships (2022): We have three new partnerships: First Nation Capital Investment Partnership (FNCIP), Nesika Services and Alberta Newsprint Company. These partnerships are in the development phase and will provide economic benefits for the Nation. (For more information see Pages 21 & 22)
- United Nations Youth Assembly (2022): We will be sending a delegate of Alexis Youth to the 27th Session of the Youth Assembly, August 12-14, 2022 at the Convene Center in New York City. The Assembly will cultivate a global network of young leaders and changemakers through exchange, education, action and impact. We will have both Alexis Youth Council and Chief Aranazhi School Youth participate in this assembly. TOTAL CASES REPORTED (March 2020 - March 2022)

First case reported on October 24, 2020

- 2 active cases reported in Alexis #133 Reserve.
- Total on Reserve recovered cases: 308
- Self reported Antigen on Reserve: 62
- Active Antigen Self-Reported: 2
- COVID -19 Vaccinations (2 doses): 650
- Total deaths due to COVID-19: 5 (1 on-reserve, 4 off-reserve).
- Total swabs completed (March 9, 2022): 2,774

EASING OF PUBLIC HEALTH RESTRICTIONS IN ALBERTA:

On February 26th, 2022 the Government of Alberta announced that their 3-step plan to ease COVID19 measures would move to Step 2 on March 1st. At this time:

- · Any remaining school requirements will be removed
- Youth screening activities for entertainment and sports activities will be removed
- · Capacity limits on all large venue and entertainment venues will be lifted
- · Indoor and outdoor social gathering limits will be lifted
- · Provincial mask mandate will be lifted except in high-risk settings, including on public transit,
- at AHS-operated and contracted facilities and all continuing care settings
- Mandatory isolation for COVID-19 core symptoms or positive test result remains in place

IV. Grounds (R.41(d))

7. This specific claim is filed on the grounds set out in section 14(1)(a) and (c) of the SCTA:

(a) a failure to fulfil a legal obligation of the Crown to provide lands or other assets under a treaty or another agreement between the First Nation and the Crown;

(c) a breach of a legal obligation arising from the Crown's...administration of reserve lands, Indian moneys or other assets of the First Nation;

8. Specifically, the Crown failed to fulfill its Treaty promise to provide Alexis with agricultural benefits and assistance.



Alexis Nakota Sioux Nation Governance & Accountability Update - Odaagina Nimi & the Elders Senate

UPDATE ODAAGINA NIMI (ALEXIS CONSTITUTION)) & ALEXIS ELDERS SENATE

On May 14, 2019, we gathered in ceremony and began working on developing a Constitution for our Nation. We began by inviting everyone to provide feedback through a survey. We then went out to the land to visit and spend time with our Elders, who shared knowledge about our culture, values, language, traditions, and sacred laws. With COVID restrictions, we also implemented an online meeting system to engage with the Elders and members to ensure their safety. Elders are our Knowledge Keepers and we rely heavily on their respected advice to guide our survival since the beginning of our time. Our Elders remind us of their responsibilities in our community and it is our intent to have these responsibilities transcribed for future generations to follow. This process is ongoing and we will continue working with the Elders until it is completed.

At the Council table, we've had many discussions and agreed it was necessary to modernize our regulations and begin restructuring our laws. All of our laws will connect with our Constitution. We envision this similar to our Eagle Staff which represents the People. In September of 2020, we presented a proposed Constitutional Outline. We will continue meeting with our Elders to write our laws respectfully and incorporate our culture.

Our current AFN Customary Election Regulations (1997) has an empty "Schedule D - Senate of Elders." In fact, former Chief Roderick Alexis spent time developing a draft elders senate schedule. Unfortunately, it was never implemented. Since the passing of our Election Regulations (1997), leadership has practiced our customary laws in calling Elders to meet with leadership for advice. A special acknowledgement to Elder Styliva Aginas who took the time to meet with the leadership (2020), to discuss the status of the Elders Senate. It was always our intention to have the Elders create this law for themselves. On the cultural side, our Elders are here and guide us, but legally, there are no structures or laws written. As we develop the articles of our Constitution, it only makes sense to locate the Elders Senate under our Constitution. Developing our Constitution is helping us strengthen our Governance Structures and we will continue working on this for the benefit of our People and Nation.

JUSTICE UPDATES BY COUNCILLOR DARWIN ALEXIS

Peace Officer By Law

The Alexis Nakota Sioux Nation received employer status from SOLGEN (Solicitor General of Canada) to employ Peace Officers on the reserve lands, # 133, 232, 233, & 234. Peace Officers will provide community based services, protection, and safety within jurisdictional and traditional boundaries of our community. Part of this process requires the Council to approve a Peace Officer By Law prior to the hiring of the Peace Officer. Council met with the membership on January 19, 2022 to review the proposed bylaw. Overall the meeting was positive and Council will call a Special Meeting to vote on this new law, in the new fiscal year (TBA).

To date we have a Curfew Bylaw (2008), Trespass Bylaw (2008) and Residency Bylaw (2015). The Peace Officer Bylaw is being added to enforce our laws, and manage calls from the Alexis #133 & #232 Residents. This is an important part of enforcement and we need members to support it.

CTA (Community Tripartite Agreement):

Last spring a decision was made to transfer our policing resources from Mayerthorpe Detachment to Parkland Detachment (Spruce Grove). As of right now, we are still receiving services from Maythorpe. Members please contact Mayerthorpe Detachment for assistance and complaints at 780-786-2800 or 780-786-2291.

This is a historic collaboration between our neighbor Nations to invest and acquire assets collectively. With shared values at the centre, the FNCIP team will work with government and industry in Alberta's Industrial Heartland to invest in their respective communities for future generations.

Nesika

Services

On January 24, 2022, we formally announced our partnership with Nesika Services. Nesika Services is a grass roots, Community led Not-for-Profit acting on behalf of any unrepresented impacted Indigenous groups in a negotiation with Canada to maximize economic opportunity in the ownership of the Trans Mountain pipeline.

Our community, *Alexis Nakota Sioux Nation*, is one of 14 Indigenous communities along the pipeline's route in Alberta and B.C. that has already signed on. There are 129 (Canada) identified impacted Indigenous communities to retain an economic interest in the Trans Mountain Pipeline.

What is Nesika ? We are not-for-profit organization that's been formed by Indigenous communities impacted by the Trans Mountain Pipeline. Nesika is not seeking to buy the pipeline. We are wanting to facilitate and support communities in negotiating and structuring the best transaction possible. Our sole purpose is to support the communities to negotiate a transaction which sees Indigenous communities have an ownership stake in the Trans Mountain pipeline project that values Environment, Governance and economic benefits equally. We are not-for-profit: Nesika will not seek or receive any profit from a transaction. We do not have a predetermined pipeline operating partner or financial backing from banks. ANC - Alberta Newsprint Company

We are working on a project with Alberta Newsprint Company (ANC). ANC is a leading manufacturer of premium newsprint in North America. They are located in Whitecourt, Alberta.

Alberta Newsprint Company (ANC) is an unincorporated joint venture owned equally by Whitecourt Newsprint Company Limited Partnership (*whose general partner is a Stern Partners company*) and West Fraser Mills Ltd. Ronald N. Stern was instrumental in the development and start-up of ANC, a \$400 million greenfield project completed in 1990. The ANC mill is among the lowest cost and highest quality newsprint and high bright paper manufacturers in North America.

Associated with its newsprint operations, ANC Power has recently commissioned a stand-alone, gas-fired reciprocating engine power plant capable of providing approximately 65MW of electrical power for use by the newsprint mill or for export to the Alberta power grid. The power plant will operate as a 'peaker' plant, being taken on-line or off as warranted by fluctuations in market power prices.

In 2013, ANC Transloading Inc. located at the ANC mill site, commenced operations with two transload facilities that provide rail access for inbound and outbound materials in West Central Alberta. The new Marsh Head transload facility, which is now under development, complements the current ANC Transloading operations adjacent to the mill in Whitecourt.

Leadership Update

- The new leadership team is in place, with Mark Fox as COO replacing Ryan McQuilter, Mike Heck replacing Paul Poscente, and Ross Morrison leading sales and relationships. The new board has been in place for 3 meetings.
- The business had a record year, \$186 million in sales, and has close to 700 employees currently within the company, all divisions are fully loaded with work, in most cases until the end of the year. Pipeline activity is the bulk of the activity that is taking place. Backwoods is nearing breaking the \$200 million in revenue per year, which makes it one of the largest First Nations-owned businesses in Alberta. A new strategic plan is being developed which will show how the company will continue to grow and also diversify from projects only into a sustainable full scale general construction company.
- A new process for ensuring Alexis Members have access to jobs and opportunities is being put in place. Forestry And Access

- Most clearing on Keyera Kaps is completed for the year.
- Work on Trans Mountain as well as TC Energy Compression is taking place.
- Recent work at Chevron in partnership with Sturgeon First Nation.
- Matting is building 250 matts per day and has been at full production all year.
- Backwoods is laying mats from the Sumas Border in BC all of the way to Manitoba. o 2022 will be another busy year for the matting division.
- It is a successful year of reclamation at Teck Cheviot mine.

Civil Division:

- Both large civil projects, Keyera and Cascade, are wound down until summer.
- Large projects won in reclamation with CNRL removing wellheads, cleaning up leases and removing facilities. This is a new venture for Backwoods.
- Backwoods partnering with large general contractors as a sub, entering the commercial and light industrial civil business ie: Chandos Construction, Bird Construction and PME Construction.
- Mechanical work continuing with integrity digs on TC Energy, Trans Mountain and Pembina Pipelines.
- The spill at Whitecourt Reserve will be cleaned up by Backwoods, with work expected to start in late 2022.
- More equipment being purchased to self perform activities, versus rental equipment.

Environmental Services

- Have become among the largest Indigenous service providers within the \$1 billion Alberta Site Rehabilitation Program.
- Within the Alberta Site Rehabilitation Program we are working for: CNRL, Vermilion, Cenovus, Ovintiv, Long Run Exploration, Obsidian, Bonavista, Perpetual Energy, Cardinal Energy, Harvest Energy, Taqa North, Vesta Energy, Clearview Resources, GL Petroleum, Razor Energy, CLEO Energy, Karve Energy, Rolling Hills Energy, Sprocket Energy, Silverleaf Resources, New Star Energy, DCP Oil Corp, Sabre Energy, Pine Cliff Energy, Torxen Energy, Journey Energy, TransGlobe Energy and Athabasca Oil Corp.

Alexis Nakota Sioux Nation Eagle River Casino & Travel Plaza Update



UPDATED BY ERIS MONCUR, CEO (2021 Q4)

On reopening on June 10th after a 6 month closure the Casino initially performed better than budget until the province announce the imposition of the vaccine mandate on September 20th. The vaccine passport resulted in a significant drop in visits to the Casino, and depressed revenues across the board.

The vaccine passport was implemented in anticipation of the Delta variant, which was quickly followed by the Omicron variant, which became the dominant strain in November. The province deployed 2 field hospitals as daily Covid 19 infection rates rose across Canada to 300% of previous levels, exceeding 30,000 cases each day. Record numbers of infections were recorded nationally beginning December 19th, 2021, as the Omicron variant of the Covid 19 virus spread through the population in at an unprecedented rate.

For the period, Slots and Food & Beverage saw significant shortfalls versus budget, largely in response to even tighter restrictions placed on guests by the province. The Travel Plaza saw revenues that exceeded budget on rising fuel sales.

Catering activities were vital in driving gaming numbers in Q4. Christmas parties helped to create additional visits in December that brought incremental, yet much-needed, revenue increases for slots and tables.

Due to the very low number of visits during this period, the property relied on cash on hand to fund net cash outflows resulting from operations for Q4 2021. All non-essential spending was curtailed, including marketing activities.

Throughout this 2-year disruption, the ability to obtain grants has allowed the property to make some very significant and unexpected advances. These programs are being phased out, but Q4 revenues were augmented by a very proficient grant application program.

A Look Ahead

The vaccine passport was lifted on February 9th, 2022, and the Casino immediately saw a rebound in activity that was as dramatic as the decline observed when the vaccine mandates were announced in September 2021. After showing significant weakness in January and the first half of February, the Casino is seeing unexpected strength as slot and table play recently achieved levels of play that had not been seen since 2016.

As early signs indicate that a reasonable recovery is on the horizon, the property will look to re-engage the marketing activities that were interrupted by the pandemic. The property plans to unveil a luxury automobile as the major promotional giveaway for 2022. Additionally, activities that guests enjoy, such as the birthday parties, will resume in several weeks.

While 2022 is expected to be challenged because of the depth of the pandemic effects, it is reasonable to expect that with targeted reductions in expenses and aggressive marketing efforts, much of the ground that was lost in the first 6 weeks of 2022 can be reclaimed.

COMMUNITY UPDATE:

The Nakota Crossing Petro Canada is governed by the Nakota Crossing Ltd. Board of Directors who meet on a quarterly. In April of 2019 the Board appointed a Chief Operating Officer (COO) to spearhead the sourcing of financing and development of the construction to completion. Since the completion of the project the COO was tasked with the responsibilities to oversee the overall operations of the business (i.e. banking agreements; addressing legal matters; meeting with store management; reviewing financial reports; making recommendations to the Board of Directors; etc) on behalf of the Nation. The role and responsibilities of the COO falls under extra duties of the Nations Economic Development Officer. The Petro Canada has now been in full operation for 19 months (Opened to the public: July 29, 2020). The chart below depicts its current operational structure.

Visitors:

The education department is currently implementing the exemption program as introduced to the province. Anyone who enters the building must provide QR code or proof of vaccination. If they are not vaccinated, they must provide proof of a negative test within 72 hours and do a rapid antigen test before leaving the front office.

Covid update - Both Chief Aranazhi and Alexis Primary School are currently maintaining all current Covid protocols. Masking mandates remain in place for all staff, students and visitors. We have switched to on-site testing for students and staff who present with symptoms. When a student tests positive, we contact the parent/guardian for pick up, send home rapid antigen test kits for the household and ask parents/guardians to test their other children daily and to follow isolation protocols. The board will reassess current Covid protocols by March 25, 2022 to determine whether the school will follow suit with the province.

Attendance - Current attendance levels are at an all time low, to help combat this issue we will be sending an employee, Sonya Alexis, into the community to visit households, helping to bridge the gap between the home and the school. Research has shown that regular attendance in school may be the greatest factor influencing a students academic success. Monthly attendance numbers are attached below.

Driver's program - Education partnered with YouthHub to help deliver our first ever driver's program with the school. We have scheduled an orientation with students and parents/guardians on March 1 & 2, 2022 to go over expectations of the program and schedule. The program will commence on March 2nd, 2022 and will run on Tuesdays, Wednesdays, and Thursdays until June. Priority is given to Alexis school students and if there is any availability then we will expand to Alexis youth living on reserve and off reserve. See poster attached.

Open gym nights - Programming started on February 23 and will continue Monday to Thursday from 6:00pm - 9:00pm. Access has been provided to Felix Kootenay for use of the gym and fitness room in Chief Aranazhi School on the days indicated above.

Literacy - Suspension of face-to-face instruction in schools during the COVID-19 pandemic led to concerns regarding student learning and achievement. In order to combat the likely regression of student skills, particularly in the area of literacy, immediate action was required. After many meetings it was determined that a four-week summer program, focusing primarily on Literacy, would provide students with the greatest opportunity to regain skills lost throughout the 2020-2021 school year. With that in mind, we chose the Fountas & Pinnell Leveled Literacy Intervention program as our method of instruction. Fountas & Pinnell is a powerful, short-term intervention program that provides daily, intensive, small-group instruction, to students who are not achieving grade-level expectations in reading. Overall, summer reading programs have been shown to improve student-reading skills, mitigate summer learning loss, improve their comprehension, and further develop their memory skills. During the last three days of the summer program, a sample group (40%) of the programs best attenders were assessed using the The Fountas & Pinnell Benchmark Assessment Systems, which provide teachers with precise tools and texts to observe and quantify specific reading behaviors, and to determine students' instructional and independent reading levels. Through this testing, it was determined that 81% of students had moved up one or more reading levels after completing the summer program. These results exceeded all of our expectations, and provided justification for additional summer programs. We are currently in the process of planning a modified three week program for the summer of 2022, which will run from July 11-29, 2022.

We are currently operating a Literacy Support Program within the school, Krista Dallmann is the Literacy Coordinator and Margaret Petawaysin offers literacy support. Various programs and resources are utilized within the program, including Jolly Phonics, Phonemic Awareness Heggerty, Fry's Words, HandWriting Without Tears and Fountas & Pinnell LLI. The Literacy Support Program began in October 2021 with reading assessments, based on these assessments, students were grouped by needs and grade level. Currently 35 students are being seen in this program. Additionally, whole class intervention is being offered in Grades K-1, this includes helping to develop a strong foundation in literacy through phonics, phonemic awareness, fluency and vocabulary. Re-assessment of reading levels took place in February and schedules were altered to reflect new student levels. Through this reassessment we saw growth for 92% of students that regularly attended with most having gone up 1 to 5 reading levels. For the three students who attended but did not show growth we are reassessing the strategies used and determining how best we can meet these students' needs.

EMERGENCY RESPONSE TEAM UPDATE

The Council concluded the State of Emergency Order (March 2020) and has authorized Duane Kootenay, Tracy Potts, Dale Alexis, Paul Q. Kootenay & Crystal Potts to continue operating under COVID Relief.

Activities carried forward BY ERT from last report:

- At this time the ERT is still planning for Covid-19 Pandemic and is now in the recovery phase.
- We currently have 7 members working ongoing with assisting in deliveries of PPE and food security.
- As of November 24, 2021 Here are the ongoing projects of the emergency response team: Childrens Covid-19 vaccinations ages 5-11 is not mandated yet to be determined.
- Booster shots available for on/off reserve members by appointment only.
- Proposal for 2nd harvest funding has been completed and submitted for \$100,000 November. 24. 2021
- \$275,000 was received for food security ICSF Q4.
- Homeless are being fed from Monday-Friday by Daycare staff. The food is currently being delivered to the members.
- Remaining funds will be allocated for food security.
- Local state of Emergency hasn't been lifted.
- Currently planning for 5th wave of Covid-19 is in progress.
- The Province will see inflation of food in the next coming month due to the disaster in BC. We are urging members to make sure food is always stocked.

Training

Additional training will take place for the following areas in March 2022. Emergency response team will be taking a 2-day training, the objective of this course is to understand the Incident Command System organization appropriate to the complexity of the incident or event.

1. ICS 200 - Incident Command System

The Incident Command System (ICS) is a standardized approach to the command, control, and coordination of emergency response providing a common hierarchy within which responders from multiple agencies can be effective. This independent study course is designed to enable personnel to operate efficiently during an incident or event within the ICS.

February 2022 – COVID 19 GIFT CARD DISTRIBUTION
