## Alexis Nakota Sioux Nation Message from Alexis Chief and Council

Abawashded,

As per Customary Election Regulations, we are pleased to present our report closing off the 2019-2020 fiscal year. As we move forward, we want to thank the elders for their prayers and guidance. We also want to thank our staff for their dedication to our Nation. It is a privilege and an honour to serve our community as Leaders, and Public Servants. Collectively, we are committed to serving our community to the best of our ability.

With the recent development of the Coronavirus in our territory, we have taken the necessary precautions to mitigate the impact and want to ensure the wellbeing of our people. We don't know what is going to happen in the next few months but we will continue to communicate with federal and provincial governments and keep everyone updated on this global pandemic.

On March 13, 2020, we gathered with the elders for guidance and established an emergency team that will be going door to door surveying the community and setting up a plan for emergency aid in the case of an outbreak. On Sunday March 16, 2020, our government made the decision to shut down the school, daycare and all activities relating to social and recreational gatherings. All staff are expected to continue working. Those experiencing symptoms are asked to stay home and continue working from home for the people. We hope this will reduce the risk of exposure. In the meantime, we are committed and will continue working for the people and implementing our plans for the best interest of all members.

Recently, we did some strategic planning for the community. We want to focus on four (4) main areas of community development. Through our strategic planning process, we have come up with the following priorities that will address community needs:

- 1. Governance & Accountability
- 2. Communication & Reporting
- 3. Economic Development
- 4. Infrastructure

These priorities are achievable and will support the growth of our community in a healthy but productive way. We will be moving ahead with committee work. (See page 7 for details.) In this report, we have also included a breakdown of our financial status covering 2013-2019 to provide an overview of the past seven (7) years of band operations and where we are at economically.

This coming year we will be opening our new Truck Stop (April 2020), our New Court House (April 2020), our New Lands Consultation Office (June-July 2020), and our New School (December 2020), We are investing in projects that will support our community culture, wellness and businesses. #### COVID-19 UPDATE:

Alexis is communicating directly with the provincial and federal governments regarding the ongoing development of the Corona virus. On March 11, 2020, the World Health Organization declared COVID-19 outbreak a pandemic. We ask that members traveling in and out of the community take extra precautions when returning. We recommend traveling only if absolutely necessary.

#### **TESTING AND HEALTH SERVICES**

If you are feeling unwell or showing any signs of illness, please self-isolate for 14 days. Symptoms of ANY illness is enough to take precaution and stay home for the recommended two weeks. In order to protect one another, we must follow the recommended safety measures in place to slow the spread of the illness. Please practice social distancing to minimize the risk for our Elders and more vulnerable members. Drive thru and/or mass testing are becoming available, however are only provided through referrals from Health Link. Alberta Health Services is working to increase the capacity and resources for testing and health services. If you feel unwell, please do not visit your Doctor's office or local hospital. Please call 811 if you are experiencing flu-like symptoms. If it's an emergency situation, please call 911.

## **ESSENTIAL SERVICES AND SANITIZATION**

Essentials such as water, waste, garbage, road maintenance and the store will continue to operate and maintain services. We are submitting bulk orders of food and water in preparation for potentially quarantined families or if the Nation has to be put on lockdown. We will stay in touch with off reserve members, if they're quarantined we will provide supports at that time. We are ordering cleaning kits for all homes and expect to have them ready this coming week. In order to provide kits, we will need the number of people in each home and the homeowners contact info. Please send this to Dorian Alexis.

#### ANSN OPERATIONS

Schools and Daycares are now closed *indefinitely*. As of now, the office will be operational with local staff only until further notice. Health and social services are still available and operating. All staff who are in Edmonton may work from home. Again, if staff have ANY flu like symptoms, please stay home.

## **COMMUNITY CARE**

We have hunters out right now and they are providing us with regular updates. They have and will provide for Elders, disabled, low income and other vulnerable families in the community. We will continue to send hunters out to support as many members possible. Elders have been engaged and will be providing traditional medicine for members as needed. ## $\underline{\mathsf{THE ROYAL PROCLAMATION}} \longleftrightarrow \underline{\mathsf{THE BNA}} \longleftrightarrow \underline{\mathsf{ALEXIS TREATY}}$

The Royal Proclamation of 1763 established the treaty-making process. In Canada, there are historic treaties and modern treaties (*also referred to as comprehensive land claim agreements*). The Government of Canada recognizes 703 historic treaties in Canada signed between 1701 and 1923. These treaties include:

- Treaties of Peace and Neutrality (1701-1760)
- Peace and Friendship Treaties (1725-1779)
- Upper Canada Land Surrenders and the Williams Treaties (1764-1862/1923)
- Robinson Treaties and Douglas Treaties (1850-1854)
- $\rightarrow$  The Numbered Treaties (1871-1921)
  - → Hugakebi Alexis signed Adhesion to Treaty No. 6on August 21, 1877

The numbered Treaties are the most prevailing in terms of Aboriginal Title and Lands. As a nation, we remind Canada that we have a unique Treaty relationship and are bound to uphold it, through ceremony and the highest law, *our Creator*.

Canada's development of Indigenous Rights Framework consists of legislation and policy development in partnership with Provincial and Territorial stakeholders. Alexis has not been called to be a partner in developing legislation and policies for Canada. As a government, our goal is to continue modernizing and writing our internal traditional and customary laws which supports our rights as a sovereign Nation that entered into Treaty. Our Treaty relationship with Canada will continue to be governed on a Nation to Nation basis

The Council met with the law firm Ackroyd in December of 2019 for an update on the status of our claim. Once our claim is validated, we will begin negotiating with the federal government. ## Alexis Nakota Sioux Nation Constitution Update

## **OVERVIEW & UPDATE**

On August 21, 2019, at the Alexis Treaty Day – 142<sup>nd</sup> Anniversary of the Adhesion to Treaty Six, the ANSN Constitution Survey results were reported to the Council and shared with the members.

In October of 2019, we received seed funding from Indian Affairs to support our project and research.

In November of 2019, our in-house lawyer was tasked to develop a draft constitution for Alexis.

In February of 2020, our in-house lawyer, Deanne Kasokeo decided to move on from Alexis. On the interim, we recently appointed Ms. Chasidy Alexis as a Policy Analyst to continue assisting us in this work.

We were planning to call a meeting with the elders this month (March 2020), for advice on band laws and developing our draft constitution; however, due to the current health pandemic situation, we are holding off. We will provide the community and elders with updates as they arise.

## 2019 ANSN CONSTITUTION SURVEY - What are our beliefs, values and principles as a community? (Feedback from the elders)

- Beliefs and values were passed on by our parents and grandparents for generations.
- Come together at ceremonies. Respect. Elders first.
- Cultural aspect but not all people believe culturally.
- Everything that we live for.
- Hunting. Provide for family. Education. Work hard. Sweats. Sundance. Live off the land. Language. Soup dances.
- I value our ancestral teachings and sundances/soup dances and just wellbeing and praying in the early mornings.
- My belief is to our Creator, God in other words. We as a community, we as a whole should get together, maybe, on a weekly basis. Also invite the teenagers and children. Let them know its very important to attend, it regards future events.
- Native culture and help out native culture.
- Not sure but they should show the elderly respect and fix their homes. Some of us value our homes, that's all we have. Take more care of elders.
- Our different faith Christianity and traditions. Respect without discrimination. Helping one another not just families.
- People of the land
- Respect an elders
- Respect one another. Supporting each other no matter what. Eg. Funerals. Smudge yourself. Thank God you're alive. Learn to let go of your anger. Put it down. Everything you put out, comes back.
- Spiritually mixed I believe. I'm Catholic myself.
- The Creator. Our stories. Respect. Women to women duties. And men to men duties.
- The teachings of our upbringing of our families from our parents and grandparents.
- The value is to try and work out somehow to get rid of all crime, drug abuse and try to get treatment for the ones who need it.
- The values we have is next to none. We lost the respect of each another and become to judgmental. Too much conflict in community regarding beliefs. Christianity and tradition and even with the traditions.
- There are traditional and the white way. I believe the white ways are kind of force on our people through converts. Totally destroy the native community. Our values should be our children but kids are left out most times. Our principles are lacking from all the drugs going on.
- We should protect our rights especially health. Health we need our rights they took away.

## 5. Alexis Child Welfare Law

- **3.** Shannon Alexis (A former grade 12 graduate of Alexis School, she currently holds a Bachelor of Arts from the University of Alberta and is serving the community on the New School Planning Committee.)
- **4. Dr. Hughie Jones** (A recent graduate from the University of Victoria with a Doctorate in Soil Science. Dr. Jones is currently serving the community as a Researcher on the Alexis Climate and Lakes Project.)
